

Consent to application for travel document for children below 18 years and minors

This form must be completed if you have children under the age of 18 or who are incapacitated and who needs a travel document. If you have several children, you must fill out one form for each child.

The form only applies to this current application for travel document, and not for future applications for travel document.

Here you can see who should fill out the consent form. Read points 1 to 4 and check if any of the options apply to you.

You are a parent or have parental responsibility

You cannot meet with the child when submitting the application for a travel document to the police

- You must submit the completed consent form.
- You must also enclose original identification with photo and signature (passport, driver's license, bank card) or publicly certified copy of such identification.

You do not live in Norway

- You must show up at your nearest Norwegian foreign service mission.
- · You must submit the completed consent form.
- You must also enclose original identification (passport or other identification) with photo and signature.

You are a guardian

- · You must submit the completed consent form.
- You must attach documentation that you have been appointed as guardian (decision from the county governor / state administrator), and a copy of identification.

The child welfare service has taken over parental responsibility

If the child welfare service has taken over the care of the child, they are the ones who must give written consent when it is to be issued

travel document for children under 18 years. They must

- provide written consent for the issuance of a travel document, and
- provide documentation that the care has been taken over of the Child Welfare Act § 4-8, cf. § 4-12.

Foster parents

If the child welfare service authorizes the foster parents, the foster parents should meet at the police station together with the applicant to submit the application. Then the

- The child welfare service must then fill out the UDI's form for authorization, and
- the foster parents must bring the completed power of attorney to the police station

If a guardian has taken over the care

The guardian must give written consent for persons who are incapacitated. The guardian must

- attach documentation that the person has been appointed as guardian. It can be a copy of a decision from the county governor or the State Administrator, and
- attach a copy of their ID

You can withdraw your consent

You can withdraw your consent any time. Then you must contact the police where you live, or a Norwegian foreign service mission.

About parents, guardians and child welfare

- If both parents have parental responsibility, both must sign below on the form.
- If only one of the parents has parental responsibility, only this person must sign.
- If the child does not have parents, or the parents do not have parental responsibility, it is the guardian or child welfare service who must sign.
- If only one parent shows up with the child to submit the application to the police station or at the embassy /the consulate, the other parent must have signed in advance, and a copy of the ID must be included with photo and signature for the parent who does not show up.
