

Accessing, correcting or deleting Schengen Information System (SIS) data

What is this form for?

Use this form to access, correct or delete information registered in the Schengen Information System. You may make the request for yourself or for another person.

If the registered person is under 15 years of age

A parent/guardian may fill out and sign this form to make a request to access, correct or delete data registered about a minor (under 18 years old) under their charge. The minor should be informed about the request.

Pursuant to the Police Databases Act, anyone 15 years of age or older may submit a request on their own.

Submitting a request on someone else's behalf

Lawyers or others requesting to access, correct or delete another person's data must present a power of attorney.

To submit your request

- 1. Fill out, print and sign this form
- 2. Make a copy of a valid ID (i.e. not expired). Acceptable forms of identification include:
 - Passport (not emergency passport)
 - Norwegian driving licence
 - Nordic driving licence of EU/EEA standard
 - Norwegian Ministry of Defence ID card (from 2004)
 - ID card issued by Posten after 1 October 1994
 - National ID card issued within the EEA
 - Asylum-seeker card with signature and place of birth
 - Norwegian refugee travel document (green passport)
 - Norwegian immigrant's passport (blue passport)
