

Application for exemption from test requirements for Norwegian citizenship

You are to fill out this form if you have registered an application for Norwegian citizenship and you

- are requesting to be exempt from having to pass a test of spoken Norwegian at the required level due to exceptional health-related or other critical factors, or other personal circumstances

and/or

- are requesting to be exempt from the citizenship test due to health-related or other critical factors, or other personal circumstances that prevent you from passing the test

Supplementary forms

To ensure that we at UDI have all the necessary information to assess your application, we need documentation stating something about your ability to learn Norwegian or to take the tests.

When you tick the box for the reason(s) for your exemption request, you may receive a notification instructing you that you must also submit

- [a form to be filled out by healthcare personnel \(udi.no/supplement1\)](https://udi.no/supplement1), and/or
- [a form to be filled out at an institution of education, special needs education or pedagogical-psychological services \(udi.no/supplement2\)](https://udi.no/supplement2)

It is important that you use these same forms when collecting a statement from a doctor or other healthcare professional to ensure that we obtain the exact information we need from them.

If you already have documentation that shows the reasons why you are requesting an exemption, you may submit it without handing in a supplementary form. In such case, it is important that the information is up to date so that we will be aware of your current or future possibilities for taking the tests.

Where to submit the form?

You are to hand in the form(s) to the police together with the other documents you submit with your application for Norwegian citizenship.

Write your name exactly as it appears in the National Population Register (Folkeregister). If you are not registered in the Population Register, you must write your name exactly as it appears in your travel document..

Reasons for requesting an exemption

If there are health-related factors or other personal circumstances that prevent you from passing the test at the B1 level, you must still pass a test at level A2.

If there are health-related factors or other personal circumstances that prevent you from passing the test at the A2 level, you must also request to be exempt from that requirement. **If that applies to you, tick both of the first two boxes.**

If there are health-related factors or other personal circumstances that prevent you from passing the citizenship test or the social studies test in Norwegian, you are to **tick the last box.**
